About PAFSS

Who are we?

We work across Doncaster borough providing families with children from 0 to 19 years with support to make a positive difference to their family life.

Our service is divided into four geographical areas throughout Doncaster – known as Central / North / East / South.

We work closely with other services such as Family Hubs, schools, health and social care to provide a flexible tailored package to support you and your family.

We aim to support parents and carers in developing the knowledge, confidence and skills that will help them to build a strong family life and keep children and young people safe, happy and successful.

What you can expect from us?

Over the first 30 days, your allocated Family Support worker, will talk to you, your children and wider family, to gather information which will help them make a decision about:

- What is going well for your family?
- What are the worries?
- What needs to happen?

Your worker will also speak to your child's school and other professionals involved, completing an Early Help Assessment.

When the assessment is finished together with you and your children your worker will put



together a plan, this will help you to understand what needs to happen and who will do that.

There will be regular meetings so that everyone around your family can update one another and check that the plan is working.

What do we do?

We offer a wide range of support for parents which can be delivered on a one to one basis and also in a group setting these include:

- Solihull Parenting Programme
- Online Solihull Parenting Programme
- Triple P
- Incredible Years
- 123 Magic

We are able to provide support children and young people to address issues such as:

- Self Esteem / Confidence
- Anger Management
- Appropriate Relationships
- Sexual Exploitation
- Staying Safe

Where appropriate we may be able to make a referral to specialised services or other agencies to meet individual needs.
